## SUSSEX CATTLE SOCIETY

Report of a Meeting of Council held on Wednesday, 8th November 2023 at 1.30 p.m.

**1. Apologies for Absence** were received and noted.

# 2. Confirm Minutes of Meeting held 13th September 2023

The Minutes were approved and signed.

### 3. Matters Arising

### a) On-Line Sale, Bull Catalogue

It was noted that if we wanted to raise prices and do something proactive to combat the unwillingness to have purchase and sell at live sales due to health issues a move towards online sales might be the solution. The only way this would work is with commitment from vendors.

It was noted that SE Marts were very interested in working with us with the proviso that there were sufficient entries to make the event viable.

A number of Council members indicated that they would be willing to support such a sale with entries of bulls and females.

Several members of Council indicated that they felt the quality of the animals forward need to be high and possibly monitor this. It was felt that it would not be possible to ask breeders to support and then say "your bull is not good enough". The price of bulls had risen to £5/6k but has dropped to £3/3.5k and we need to work to get the price back to where it should be and this to be seen publicly.

The Chairman stated that an agreement by Council to go forward needed to be made by the year end to enable breeders to be notified.

It was agreed to have a Zoom meeting in December to finalise plans.

## b) Nigel Ventham Legacy

It was agreed that Council would give consideration on how the £1000 should be used.

#### c) Exhibition Trailer

The question was raised on the viability of the exhibition trailer in terms of costs and benefits. There was some discussion with a division on whether the trailer should be sold or carry on being used at shows. This will be discussed further in relation to publicity and promotional spend.

## 4. Finance Report

#### a) Bank Balances

Balances were reported as Current Account £5,792, COIF Deposit Account £21,739 compared with a total of £42,064 for the same period las year.

### b) Preliminary Income & Expenditure 2023

Details of a draft Income & Expenditure report for the main items of income and expenditure had been circulated, noting that this was not final as some aspects and adjustment had not yet been made. It was generally agreed to wait until more information become available to consider the results. It was further noted that there was a high possibility of a deficit for the year.

#### c) Fees for 2024

The fees were discussed and it was felt that due to the potential shortfall of income over expenditure, the fact that all costs had risen considerably due to the rise in inflation and that fees had not been increased for a number of years the following fees would be charged from 1<sup>st</sup> January 2024. The fees were amended and agreed by those present.
